1. Eligibility

To be eligible to enter this Promotion, an entrant must:

- Reside in New South Wales
- Be 18 years of age or older at the time of entry
- Make one or more purchases meeting the Qualifying Spend at one or more participating retailers at Mason & Main during the Promotional Period
- Complete the entry form and provide all mandatory entry details, including opting in to the Mason & Main database

Employees (and their immediate family members) of the Promoter, Mason & Main centre management, and any participating retailer at Mason & Main, together with any agency directly associated with the conduct of this Promotion, are not eligible to enter.

2. How to Enter

To enter the Promotion, entrants must complete the following steps during the Promotional Period:

1. Visit Mason & Main, 1 Main Ln, Merrylands NSW 2160, and make one or more purchases from participating retailers that together total \$25 (AUD) or more (inclusive of GST) in a single calendar day (“Qualifying Spend”).
2. Qualifying Spend may be accumulated across multiple receipts from different participating retailers, provided all purchases are made on the same calendar day.
3. Each receipt may only be submitted once and cannot be reused to support more than one entry.
4. Entrants will receive one (1) entry for each Qualifying Spend. There is no limit to the number of entries an entrant may submit during the Promotional Period - an entrant may enter as many times as they like, including multiple times on the same day, provided each entry is supported by different receipt(s) evidencing a separate, non-duplicated Qualifying Spend of at least \$25 (i.e. the same receipt(s) cannot be used to support more than one entry).
5. Scan the QR code displayed at Mason & Main or visit [Spend & Win - Mason & Main](#) and upload a clear photo or PDF copy of the qualifying receipt(s).
6. Complete and submit the online entry form, providing all mandatory details.
7. Join the Mason & Main database to receive future marketing communications.

8. Retain the original qualifying receipt(s) and produce them to the Promoter upon request for verification purposes.

Receipts not accepted

The following are not accepted as proof of purchase for the purposes of this Promotion:

- receipts for bill payments, including credit card repayments, ATM or bank transactions, bank fees and charges, utility bills (gas, electricity, water, phone), cash advances or withdrawals, account charges, government fees and interest charges
- receipts for tobacco products, prescriptions, lottery products, currency exchange and TAB/wagering transactions
- receipts for gift card or gift voucher purchases
- No further retailer exclusions apply - all retailers trading at Mason & Main during the Promotional Period are participating retailers, subject to the excluded receipt/transaction types listed above.

No late entries will be accepted. Incomplete or incoherent entries will be invalid. The Promoter reserves the right, at any time, to verify the validity of entries and entrants (including an entrant's identity) and to disqualify any entrant who submits an entry that does not comply with these Conditions of Entry or who tampers with the entry process. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights.

3. Entries Permitted

Entrants may submit multiple entries during the Promotional Period. There is no limit to the number of entries an entrant may submit, provided each entry is supported by a separate, non-duplicated Qualifying Spend of at least \$25 (see clause 2 above) - the same receipt(s) cannot be used to support more than one entry. Each valid entry received during a given weekly entry period (see clause 5) will go into the draw for that week's Weekly Prize. All valid entries received across the entire Promotional Period will also go into the draw for the Major Prize.

An entrant may win more than one Weekly Prize during the Promotional Period, but may only win the Major Prize once.

5. How Winners Will Be Chosen

Weekly Prize draws

Major Prize draw

The Major Prize draw will also be conducted on 15 September 2026 at 10:00am AEST, at Coronation Property, Level 2/66 Wentworth Ave, Surry Hills NSW 2010, from all valid entries received during the entire Promotional Period.

Winning entries are not re-entered into any later draw within the same Promotional Period. The Promoter may draw additional reserve entries at each draw, recorded in order, to be used if a winning entry or entrant is deemed invalid or a prize goes unclaimed (Reserve Entrants). The results of each draw are final and binding and no correspondence will be entered into.

6. Prize Conditions

- Prizes will be issued as physical Mason & Main gift cards.
- Gift cards will be sent to the winner via express post, to the address nominated by the winner. The winner is responsible for ensuring the address they provide is accurate and complete. Neither the Promoter nor Australia Post (or other delivery provider used) accepts responsibility for any delay, loss or misdirection resulting from an incorrect or incomplete address supplied by the winner, or for delivery delays outside the Promoter's reasonable control.
- The winner must provide a valid postal address within 14 days of being notified. If the winner does not provide a valid address within that time, the prize will be treated as unclaimed (see clause 8).
- The winner must, upon request by the Promoter, provide valid photographic identification and any other information reasonably required to verify their identity and eligibility to claim the prize.
- Gift cards are issued by TCN Group Pty Ltd and are subject to TCN Group Pty Ltd's terms of use. Each gift card's expiry date is printed on the card itself. It is the winner's responsibility to use the gift card before that expiry date.
- If the winner does not respond to the Promoter's reasonable attempts at contact, or does not provide the information requested, within the timeframe specified by the Promoter, the prize will be treated as unclaimed (see clause 8).

7. Proof of Purchase

Entrants must retain their original, itemised purchase receipt(s) as proof of purchase for all entries. If an entrant cannot produce proof of purchase on request, the Promoter may disqualify all of that entrant's entries and conduct a redraw. Receipts must clearly show the retailer at which the Qualifying Spend was made, the items purchased, the amount spent and the date of purchase (which must fall within the Promotional Period and before the entry was submitted). If proof of purchase has been shared with, or used by, more than one entrant, all related entries will be invalid.

8. Notification of Winners and Unclaimed Prizes

As all draws (Weekly Prize and Major Prize) are conducted on 15 September 2026 (see clause 5), all winners will be notified by email on that date.

If a winner cannot be contacted, does not respond within 14 business days of being notified, or cannot provide the verification requested, the prize will be forfeited. The Promoter may then conduct an unclaimed prize draw to select a replacement winner from the Reserve Entrants for that draw, or otherwise as permitted by law.

9. Privacy

The Promoter collects personal information to conduct this Promotion, fulfil prizes, and (where the entrant has opted in) for future marketing purposes, including the Mason & Main database. 6. All retailers trading at Mason & Main during the Promotional Period are participating retailers for the purposes of this Promotion ("participating retailers"), subject to the excluded receipt/transaction types set out in clause 2 above.

The Promoter reserves the right, in its sole discretion (acting reasonably), to cancel, terminate, modify or suspend this Promotion, subject to any applicable regulatory requirements, if it is not capable of running as planned due to causes beyond the Promoter's reasonable control (including technical failure, fraud or unauthorised intervention).
